## The Farmstead at Oregon Dairy Sunflower Pickin' Days Photography Policy

Effective August 2021

### PROFESSIONAL PHOTOGRAPHERS:

We welcome those who wish to use The Farmstead at Oregon Dairy, 1289 Creek Road, Lititz, PA 17543 as a backdrop/setting for any portrait/commercial photography, even if the photographer is not compensated, financially or otherwise.

Professional Photographers will have exclusive access to the sunflower patch when the patch is not open to the public on designated dates and times. Exclusive Photography Dates Available: August 16, 17, 23 & 24 from 5pm – 9pm. Limit up to 4 photographers per session/day. Fur-babies are permitted at all of the exclusive photography sessions but they must be on a leash and please clean up after them.

- Photography Passes are available per day.
- **Cost is \$100 per day.** Photographers can book as many clients on the day pass as they choose to.
- Professional photographers must have a valid website, phone number, Facebook page and/or active Instagram page.
- Portrait photography is defined as, but not limited to: senior, engagement, family, graduation, wedding, maternity, etc.
- Commercial photography is defined as, but not limited to: catalog, fashion, advertisement, promotion, etc.

### **Check-in and Session Requirements:**

- Please check in at the ticket booth at the Creek Road Barn.
- Anyone assisting the photographer must purchase a \$7 admission ticket to the sunflower patch.
- Photography sessions must be purchased online at:

- Each photography session is valid for the day in which it was purchased and cannot be used for another session unless it is rained out.
- Each photography session purchased is for the photographer named on the pass and may not be shared with anyone else.
- Everyone entering The Farmstead at Oregon Dairy must purchase a \$7 admission ticket. Admission ticket includes one Complimentary Single-Bloom Sunflower. This includes people who are being photographed and anyone accompanying them for their session. Photography Client Admission tickets can be purchased at the ticket booth the day of the session and can only be paid for by credit card.
- Photography sessions can only take place during designated hours of the day pass purchased by the photographer.
- Photographers must send their clients names for each photography session booked, to Nancy.brown@oregondairy.com.

## OREGON DAIRY

- Please supervise all children at all times while on The Farmstead property. This includes the photographer's own children. Also, insure they are not injuring plants, and items that are growing in any way.
- Nothing may be picked and used during your session (except for the complimentary sunflower) unless they are purchased ahead of time from the Farmstead at Oregon Dairy, such as sunflowers during Sunflower Pickin Days.
- Multiple clothes changes on site are not appropriate as these can interfere with our other guests.
- Vehicles are NOT allowed under any circumstances to drive to the sunflower field. Please park in our parking field. Photoshoots can be accessed by foot.
- No props are permitted. There are props in the field that can be used for photography.
- We require that all trash is removed from your photo site.

### Important Reminders

- The use of drones is strictly prohibited.
- **Photographers and/or assistants are required to sanitize any props used by their clients after the session is completed. The Farmstead will provide the sanitizer and rags for your use.**
- All photos should be family friendly in nature.
- Please be courteous and polite to other guests.
- Our Staff is not responsible for directing clients to your photo shoot location. Make sure your clients have your cell phone so that they can contact you upon their arrival.
- The Farmstead reserves the right to halt any photography sessions deemed to be disruptive.
- The Farmstead assumes no responsibility for loss, theft, or damage to any equipment or belongings.
- Any unauthorized portrait/commercial photography sessions will be escorted from the Farmstead.
